# Health

The Revelstoke Local Health Area (LHA) is one of 31 LHAs within Interior Health and one of 9 located in the Thompson Cariboo Shuswap Health Service Area (TCSHSA).

## Population and Demographics

The population of the Revelstoke LHA is the fourth smallest of 9 LHAs located within the Thompson Cariboo Shuswap Health Service Area (TCSHSA). The median age of 40.1 is the seventh youngest in IH. Along with Grand Forks, South Cariboo, Golden, Enderby, and Kimberley, the Revelstoke LHA is one of six LHAs in IH with a population in the range of 7,000 to 10,000. Over the next five years the youth population (less than 20 years of age) of the Revelstoke LHA is projected to decline. However, the remaining age groups are projected to increase over the same period, with the largest growth expected for the 85+ age group.

## Health Status

Measures such as life expectancy at birth, low birth weight rate, and standardized mortality ratio (SMR) provide valuable information on the likelihood of enjoying a healthy, long life. Revelstoke residents have the highest life expectancy at birth (79.7 years) among the 9 LHAs located within the TCSHSA but the tenth lowest of the 31 LHAs in all of IH. The rate of low birth weight infants is slightly higher than that for IH as a whole. However, the infant mortality rate has remained relatively stable since the 1998-2002 period. The Standardized Mortality Ratio (SMR) for all causes of death for Revelstoke (1.11) reveals there were more observed deaths than expected, given provincial rates. The incidence of fatalities caused by diseases of the arteries, and motor vehicle accidents in the Revelstoke LHA were more than two times greater than expected, given provincial rates.

## Non-Medical Determinants of Health

Standard of living factors such as income, employment, and social status have a significant impact on the long-term health of individuals. In 2004, the percentage of Revelstoke residents (aged 19-64) receiving federal Employment Insurance (EI) benefits was lower than that for the TCSHSA (3.5%), but higher than the rate for BC (2.9%). Conversely, the percentage of Revelstoke LHA residents (aged 0-64 years) receiving Income Assistance as of September 2004 was lower than similar rates for TCSHSA (4.8%), IH (4.7%), and BC (4.0%). The percentage of seniors (65+) receiving the maximum Guaranteed Income Supplement (GIS) was lower than similar rates for TCSHSA (2.6%), IH (2.0%), and BC (3.5%).

## Health Service Performance

Accessibility is a key measure of health care services provided in any jurisdiction. Interior Health's network of acute care facilities provides for the provision of basic acute care services in rural communities such as Revelstoke while centralizing specialized services in nearby urban centres. Residents of the Revelstoke LHA requiring acute care services not provided at Queen Victoria Hospital (QVH) may travel to Salmon Arm, Kamloops or Kelowna to receive such treatment. In 2004/05, almost 68% of Revelstoke residents received necessary inpatient care within the TCSHSA. Overall, more than 90% of IH residents receive inpatient acute care within the health authority boundaries.

## Community and Health System Characteristics

The availability of residential care beds in the Revelstoke LHA is lower than the equivalent rate for IH as a whole. However, assisted living units and GPs are available at rates greater than that for IH. Utilization measures indicate that Revelstoke residents use the available acute care, residential care, and home support services at rates exceeding those for IH as a whole.
